

PROSPECTIVE MEMBER ACCESS

Indian Ridge homeowners who are current Members of Indian Ridge Country Club and wish to lease their home for the approved minimum of three (3) months can allow their tenants to have access to Golf or Club category membership access. Privileges run during the term of the lease but no longer than through December 31 of the following year. Under this program, the Indian Ridge Country Club Member will be responsible for maintaining their monthly dues and fees on their account and agree to relinquish their own access to the Club's facilities, programs and activities - even as a guest - during the tenant's term of their lease. The tenant's access to the Club must be approved by the Indian Ridge Country Club Board of Directors a minimum of 30 days prior to the start of the lease via the normal Member approval process. The tenant's application paperwork for the Prospective Member Access program, a copy of the lease and their prepaid fees for participation in the program are to be submitted to the Membership Office. A separate account is then set up for the tenant.

SINGLE SEASON INTRODUCTION

Prospective Members or tenants who lease from a non-member of Indian Ridge Country Club who are interested having membership privileges for a trial period are eligible to apply for Golf or Club membership privileges. Our *Single Season Introduction* program is also a trial program offered for one season only. The same three (3) month minimum term applies. No authorization for privileges is needed from the Lessor. Tenant must complete application paperwork and prepay an initiation fee deposit for their desired level of privilege. Tenant will pay full Golf or Club dues and applicable fees each month for their desired category of privilege during the term of their lease.

Please Note: *Single Season Introduction to Golf* and *Prospective Member Access to Golf* participants will have the same access and privileges as our equity Members with the exception of being able to participate as a Member in certain major golf events: Club Championships, Bury the Tomahawk, Member Guest (*can be the guest of a Golf Member*) and the Member- Member events (*can play with a Golf Member*).
